OSS Impartiality Policy has been established and implemented by Top Management for safeguarding impartiality, this policy is a commitment OSS Top Management to safeguard impartiality, manage its conflict of interest, ensure the objectivity of Management System certification, Type-A Inspection, Training, and ZED rating scheme assessment and maintain a professional environment. To meet the accreditation requirements of JAS-ANZ, NABCB, & for ZED rating scheme and to obtain the confidence of the client and interested party of OSS.

The Impartiality Policy Statements of OSS Top Management

OSS Top Management has taken responsibility and has the commitment to work impartially and maintain impartiality throughout its entire activities of OSS Management System certification, Type-A Inspection, Training, and ZED rating scheme assessment. OSS shall not allow commercial, financial, or other pressures to compromise impartiality, to provide confidence to certified clients, interested parties, and accreditation Bodies (JAS-ANZ, NABCB, and ZED Rating Scheme).

The Management system certification decisions shall be made based on the objective evidence of conformity (or nonconformity) obtained during the onsite audit and the certification decisions are not influenced by other interests and shall not allow commercial, financial or other pressures to compromise impartiality.

The Type-A Inspection activities and decision on final Inspection Report shall be made based on the objective evidence of conformity (or nonconformity) obtained during the onsite Inspection and the decisions on Inspection Report are not influenced by other interests and shall not allow commercial, financial or other pressures to compromise impartiality.

ZED Rating Assessment and Decision shall be made based on the objective evidence obtained during the onsite ZED Rating Assessment and the decisions are not influenced by other interests and shall not allow commercial, financial or other pressures to compromise impartiality.

To obtain and maintain the confidentiality of client organization, accreditation body and interested party in OSS certification process, the Inspection process, Training Process & ZED Rating assessment, and decision-making process. The OSS has formed the committee of independent person to review the OSS commitment of impartiality at regular interval to ensure that the impartiality is being maintained throughout the OSS services of certification activities, Type-A Inspection activities, Training activities & ZED rating assessment activities and to monitor the source of income of OSS.

Under the OSS Impartiality Policy Commitment

- OSS shall not certify/perform the Type-A Inspection / Training/ ZED rating Assessment to it's wholly-owned subsidiary or its parent organization.
- OSS shall not the certify/ Perform the Type-A Inspection / Training/ ZED rating Assessment to its related body i.e the other organization where OSS director is a shareholder or have any business relationship.
- OSS shall be independent of the parties involved

- OSS shall not Certify another certification body for its quality management system certification activities.
- OSS and its personnel/ staff shall not engage in any activities that may conflict with their Impartiality.
- OSS will not have or keep a commercial relationship with a client other than third-party conformity assessment / Type-A Inspection / ZED rating assessment.
- OSS and any part of the same legal entity and any entity under the organizational control of the OSS shall not offer or provide management system consultancy / ZED Rating Scheme Consultancy.
- OSS shall not be a part of a legal entity that is engaged in design, manufacture, supply, installation, purchase, ownership, use or maintenance of the items inspected.
- OSS and any part of the same legal entity shall not offer or provide any management system consultancy (Including FSMS / ZED Rating/ Type-A Inspection).
- OSS and any part of the same legal entity and any entity under the organizational control of the OSS shall not offer or provide internal audits to its clients. A recognized mitigation of this threat is that the OSS shall not certify a management system/ Type-A Inspection / ZED rating on which it provided internal audits for a minimum of two years following the completion of the internal audits.
- OSS shall not certify a management system where a client has received management systems consultancy from a body that has a relationship with OSS, this is a significant threat to impartiality. A recognized mitigation of this threat is that the OSS shall not certify the management system for a minimum of two years following the end of the consultancy.
- OSS shall not outsource audits / Type-A Inspection /ZED rating assessment to a management system consultancy organization.
- OSS's activities shall not be marketed or offered as linked with the activities of an organization that provides management system consultancy. The OSS shall take action to correct inappropriate claims by any consultancy organization stating or implying that certification would be simpler, easier, faster or less expensive if the OSS name were used. The OSS shall not state or imply that certification would be simpler, easier, faster or less expensive if a specified consultancy organization were used.
- OSS shall ensure that there is no conflict of interests, with personnel who have provided management system consultancy, including those acting in a managerial capacity, shall not be used by the OSS to take part in an audit or other certification activities/ Type-A Inspection / ZED Rating- if they have been involved in management system consultancy towards the client. A recognized mitigation of this threat is that a person shall not be used in OSS for a minimum of two years following the end of the consultancy.

- OSS shall take action to respond to any threats to its impartiality arising from the actions of other persons, bodies or organizations.
- All OSS personnel, either internal or external or committees, who could influence the certification activities, shall act impartially and shall not allow commercial, financial or other pressures to compromise impartiality.
- OSS and its personnel shall not engage in any activities that may conflict with their independence of judgment and integrity in relation to their inspection activities. In particular, they shall not be engaged in the design, manufacture, supply, installation, purchase, ownership, use or maintenance of the items inspected.
- OSS shall require personnel, internal and external, to reveal any situation known to them that may present them or the OSS with a conflict of interests. OSS will record and use this information as input to identifying threats to impartiality raised by the activities of such personnel or by the organizations that employ them, and shall not use such personnel, internal or external unless they can demonstrate that there is no conflict of interests.
- OSS Auditors/Inspector / ZED Assessor /Technical experts are prohibited for participating in the Audit of any organization to which they have given assistance, by consultancy or training (other than professionally registered auditor training), or where they have any financial or commercial interest for a minimum period of 2 years prior to the date of application of the organization for Certification/ Type-A Inspection / ZED Rating Assessment.
- OSS and its Audit Team Member /Inspector / ZED Assessor or staff shall not disclose the confidential information of Client to any third party, without consent of the client.
- All OSS directly employed Management and Staff are required to declare all financial interests or business activities on commencement and during the period of employment.
- OSS shall not undertake ZED rating Assessment of a client on which it has provided consultancy.
- OSS shall not be linked to a separate legal entity engaged in the design, manufacture, supply, installation, purchase, ownership, use or maintenance of the items inspected by the following:

- OSS Top Management will not contradict with his statement of Impartiality
1. Common ownership, except where the owners have no ability to influence the outcome of an inspection.
 2. Common ownership appointees on the boards or equivalent of the organizations, except where these have functions that have no influence on the outcome of an inspection.
 3. Directly reporting to the same higher level of management, except where this cannot influence the outcome of an inspection.
 4. Contractual commitments or other means may have an ability to influence the outcome of an inspection.
 5. Capacity Verification Activity - The Capacity verification activities /services is a potential Conflict of Interest - to Third Part Inspection activities. OSS and its Inspecting officer will not Perform the Inspection to the organization – where OSS is involves in Capacity Verification.

Commitment for Maintaining the Impartiality

(By OSS Staff, committee members, Inspecting Officer, Auditor, and other Certification Persons)

All the OSS staff, Inspecting Officer, Auditor, and other Certification Persons, (including Committee member), working on behalf of OSS – shall sign the confidential agreement with OSS – for their commitments of not allow commercial, financial or other pressures to compromise impartiality.

Risk Identification, Analysis, and Mitigation

The Potential Risk Identification to Impartiality shall be carried out as per the Risk analysis instruction OSS/QI/02, with consideration Analysis of threats to impartiality (OSS/QI/13) and Conflict of Interest (OSS/QI/14).

The Monitoring and Mitigation of Residual Risk and its control shall be verified through Internal Audit and shall be reviewed by Top Management during Management review meeting and necessary decisions shall be made to further strengthen the control and minimize the risk to impartiality.

Monitoring and Review of Impartiality Policy

OSS will monitor the impartiality policy statements compliance during Internal Audit, during the Management Review meeting and during the review of impartial committee review.
